Nasuulu Eco-Lodge is a community-owned facility located in Nasuulu Conservancy, Isiolo County. Completed in 2024, the lodge lies between the renowned Samburu and Buffalo Springs National Reserves, offering a rare investment opportunity in a wildlife-rich region. Its prime location makes it an ideal choice for investors seeking to manage and operate a tourism facility in a high potential area.

### **Available Facilities in Lodge**

- Accommodation: Three fully furnished rooms, accommodating up to nine guests. There is a camping space available for additional guests.
- Furnished kitchen with a spacious mess, dining and relaxing area.
- Large infinity swimming pool overlooking the Ewaso Nyiro River, with changing rooms and showers.
- Dedicated 5-room Staff quarters
- Secured area with conservancy Headquarters nearby.
- Large water storage tanks.
- Solar and Wi-Fi installed.

- **Wildlife presence:** Surrounded by Samburu National Reserve and Buffalo Springs, offering premium safari experiences
- **Cultural Experience:** Rich local culture from Borana, Samburu, Turkana, and Somali communities hosted by the conservancy.
- **Accessibility:** Easily accessed by road through both Samburu National Reserves or Buffalo springs gates approximately one-hour drive from Isiolo, or by Air using the Nasuulu, or Buffalo Springs airstrip.
